The contest grand prize award is \$300 with \$150 first prize awards in each category.

Photos will be judged on artistic and aesthetic quality, originality, and the appropriateness of the subject representing qualities of life and the environment that would be threatened by construction of the Prairie Parkway.

Winning images will be displayed on the websites of the sponsoring organizations and may be reproduced in publications of the organizations or displayed at events held by the organizations.

Entry Requirements:

Image:

- Created in 2007
- Subject/location within 5 miles of the proposed route of the Prairie Parkway. See map at <http://www.sprawlway.org/contest> for proposed route.
- 3 megapixel (or higher) resolution (approx. 5 x 7 inches @ 300 DPI)
- One image may be submitted in each of the adult categories. The youth category entry may include one image representing any of the three adult categories.
- All contest submissions must be original, unpublished photographs, solely created by the submitting entrant.
- No alteration or enhancing other than cropping of the digital image is permitted.

File:

- File type is JPEG (.JPG)
- File size maximum: 2 megabytes
- Filename format: *CategoryCode-FirstInitial-LastName.jpg* where CategoryCodes are Ag – agricultural; Rural – rural, small community life; Env – environment; Youth – youth 16 or under. For example: **Rural-jsmith.jpg**

Medium:

- CD-ROM, or as an email attachment

How to submit your contest entry:

Submission deadline – must be received by 5 p.m., Saturday, October 6, 2007 either by e-mail or by postal mail. Submit as an attachment to an e-mail to ppphotocontest@mac.com or on a CD-ROM sent to Prairie Parkway Contest, PO Box 334, Big Rock IL 60511.

Images may be submitted by e-mail or CD-ROM and should be accompanied by a completed application form. E-mail images must include a filed out file with the application form information
